In continuation of our WhatsApp updates above cited, members are further informed that the matter covered by M.P. No. 46 of 2024, was heard on 22.05.2025 at TNERC and a copy of the Daily Order of TNERC in the above matter is attached herewith for the information of all members, who are having Grid Connected Solar Energy Projects.

This Petition was first filed by the CE NCES of TNGECL in 2024, exclusively to modify the Solar Power Adjustment Timings. Thereafter, on several hearings, even though REPA has made very strong comments on the Petition, the CE NCES has not provided any reply to REPA. Accordingly, whenever the matter came before the TNERC, the CE NCES has sought for time during every hearing. Finally, the Cause Title of the Petition was sought to be modified and the CE-Commercial has become now the Petitioner, in the place of CE NCES. Accordingly, it looks that the Petition of the CE-Commercial was admitted and the TNERC has started further hearing.

Looking the way and the manner, the hearing is getting proceeded at the TNERC, REPA has filed a detailed Implead Petition, at TNERC, suitably to restore the interest of the members of REPA, from being not exploited, in any manner. When the matter came to be heard on 22.05.2025, the Legal Team of REPA has mentioned the fact of filing the Implead Petition and accordingly, after taking note of the pleadings of the REPA Legal Team, the TNERC has recorded the pleadings and directed the registry to post the Implead Petition of REPA, during the next hearing. The matter was adjourned to 05.06.2025 for next hearing.
